Booth sales closed at 5:00pm Friday March 15th, unless sold out prior.

10x10 booth is \$65.00 payable in cash, credit card (Visa, MasterCard, Discover, no AMEX) payable at time of booth reservation to Cumulus Media. Multiple 10x10 booths can be purchased; however, no discounted price is extended, each 10x10 space is a separate \$65.00 cost.

Vendor Set up & check in – Either Friday 3/22 from 1:00-4:00pm &/OR Saturday 3/23 6:00AM-9:00AM

Security for the event is set up with Summit Tactical & provided by CSEC (they are onsite from 8:30-4:30 day of event). The venue is secure overnight. See liability release form.

There are no military or multi-booth discounts or booth refunds or add-ons purchased.

All vendor booth assignments will be provided at vendor check in on Friday or Saturday of the event.

All add-ons (table, chairs, electricity, Wi-Fi) provided at vendor check in.

Show opens promptly at 9:00AM. Once the load in doors are closed the show opens.

Event is 9:00 am- 4:00 pm.

Tear down is 4:00 – 5:00pm

5:00-6:00 pm is final clean up and hauling by Cumulus Media & the venue. All vendors must be out of the building by 5:00pm.

At 5:00pm, the day of the event, all doors will be locked and any items remaining will be donated or recycled.

If you would like a receipt for items donated, they will be available at the vendor check in.

No sale of guns, ammo, knives or marijuana products.

The sale of food for on-site consumption is prohibited. Food vendors may sell pre-packaged food & distribute free two ounce samples.

No outside food allowed. Concessions provided for purchase by Bird Dog BBQ.

Tables & chairs are not provided as part of the booth cost; however, you can rent them, see above.

Use of Wi-Fi and electricity is not included in the booth cost; however, you can rent them, see above.

Vendor parking is in the back of the venue.

Please bring a bank of cash & change, we cannot provide this for you.

Dumpsters and trash pick-up is provided by the venue. Please break down all boxes for recycling.

Additional costs apply: (provided by CSEC or Brady's Rent All in agreement with Cumulus)

- Tables – 8 FT wood tables \$9. Each (vendors will need to check them out, cost of replacement is \$100.)
- Chairs - \$1. Each
- Wi-Fi – Vouchers are \$10. Per, payable directly to Cumulus Media on day of event.
- Electricity – on pillars and outlets throughout the venue, assigned by CSEC/Cumulus during set up – 15 amp is \$25., 30 amp is \$50., 50 amp is \$75.



LIABILITY RELEASE AND HOLD HARMLESS AGREEMENT

_____ (“Vendor”) hereby agrees that it will not hold liable Cumulus Broadcasting LLC, radio station(s) [KATC-FM, KCSF-AM, KKFM-FM, KKMKG-FM, KKPK-FM and KVOR-AM], and their parents, subsidiaries, affiliates, members, directors, officers, employees and agents (“Cumulus”) for any loss, injury or damage to Vendor’s property or the Vendor’s employees, representatives or agents, due to fire, theft, accidents, or any cause whatsoever that may arise or occur in connection with their participation in the “World’s Largest Indoor Garage Sale” event being held on March 23rd, 2019, 9:00am-4:00pm, at the Colorado Springs Event Center, Colorado Springs, CO (the “Event”).
